FACTUAL FINDINGS REPORT OF THE INDEPENDENT B-BBEE APPROVED REGISTRERED AUDITOR TO THE MEMBERS OF KTP PROCUREMENT AND LOGISTICS CC (T/A KTP PROCUREMENT AND SAFETY SUPPLIES)– REG. NR. 2004/057413/23

### Scope

- c. Determined the percentage interest held by such Black persons/women in the business.

### Procedures to verify turnover:

- a. Inspected signed affidavit for turnover reported.
- b. Inspected the letter obtained from the accounting officer to establish whether or not the turnover report was below R10 000 000.
